



Dear Sisters and Comrades,

The 20th Congress of the Socialist International Women in Cape Town saw the elections of a determined and committed Executive to carry our organisation forward for the next four years.

This commitment was reflected in the 2013 Action Plan adopted at the meeting of the Council in Lisbon, which laid down four main goals: to extend the recognition of economic and social rights; to consolidate political rights; to promote equal participation in decision-making; and to work towards respect for diversity.

The theme chosen for the first meeting of the Council, 'The International Financial Crisis and the Impact on Women' thus reflects a determination to engage with the contemporary situation and with women's own concerns.

Given this, I have sought since my election to strengthen the role of the Vice-Presidents so as to promote better contact and greater solidarity between member organisations, and to take greater account of the specific characteristics of the different regions.

Another important concern has been to strengthen the position of SIW and to promote the adoption of the 30% quota by member parties in preparation for the next step, the move to parity.

This Newsletter will allow you to follow the progress made, the resolutions adopted, and all the news from the organisation, throughout the year.

The 2013 session focused on the following key areas:
